INFORMATION TO BE SUBMITTED WHEN APPLYING:

- 1. Completed Building Permit Application .
- 2. A plat of survey showing the proposed detached garage, drawn to scale.
- 3. The proposed location shown on the plat showing distance to the lot lines and other structures. A minimum ten foot separation from other structures is required.
- 4. The detached garage shall comply located a minimum of 5 feet from the side and rear lot line.
- 5. Provide drawings or plans indicating construction details including; footing and slab details, wall and roof details, driveway dimensions with construction and size.
- 6. Maximum size: 1200 square feet or eight percent (8%) of lot area, whichever is less.
- 7. Maximum height shall not exceed 15 feet.
- 8. Electrical work shall be detailed as to where all receptacles and switches are located and where power is derived from. Indicate depth of trench, if applicable.
- 9. The footing shall be a minimum of 12 inches below grade and 8 inches above grade for garages of 400 square feet or less.
- 10. The concrete slab shall be a minimum of 4 inches of concrete over a minimum 4 inches of crushed gravel. 6 x 6 #10 wire mesh shall be installed in the slab.
- 11. The detached garage shall be utilized for storage and vehicles only.
- 12. The driveway shall be constructed with a continuous dust-free surface located between the garage and the adjoining public right-of-way or alley. Asphalt and/or concrete is acceptable. The driveway width shall not exceed 28 feet at the public sidewalk and 34 feet at the public street.
- 13. Required inspections are footing, slab, driveway, underground electrical (if applicable) and final when all work is completed.
- 14. All submitted information shall be available on site during the inspection.
- 15. **Other pertinent information:** Failed inspections will require a reinspection fee to be paid prior to scheduling the reinspection.
