AN ORDINANCE GRANTING A TEMPORARY PERMIT FOR A BEER GARDEN

Adopted June 6, 2017, by the Mayor and City Council of the City of Genoa DeKalb County, Illinois, and approved and published in pamphlet form this 6th day of June 2017.

ORDINANCE NO. 2017-

AN ORDINANCE GRANTING A TEMPORARY PERMIT FOR A BEER GARDEN

WHEREAS, the City Council has considered the businesses expressing interest in Beer Gardens;

WHEREAS, Minnihan's Irish Pub would like to have a temporary beer garden that would include a Genoa Days celebration;

NOW THEREFORE, BE IT ORDAINED by the Mayor and City Council of the CITY OF GENOA, DeKalb County, Illinois, as follows:

SECTION 1: Subject to the conditions in Section 2 of this Ordinance, a temporary permit may be issued by the Mayor to a Business that holds a valid A-O liquor license in the City of Genoa described as follows:

SECTION 2: The special permit for a Beer Garden, allowing outdoor seating, on-premises sale and consumption of alcoholic liquor, is conditioned on the following:

- a. The application shall be filed at the office of the Mayor before the effective date; and
- b. The Beer Garden shall be fenced off with a minimum fence height of 6 feet with only one point of entry and exit through the principal structure of the establishment; and
- c. The Beer Garden dates during Genoa Days are Wednesday, June 7th 2017 through Saturday, June 10th 2017; and
- d. Any Band, DJ, Radio, music and/or noise during Genoa Days shall not begin before 3:00 p.m. and end by 10:00 p.m. and shall not exceed the noise level designated by the Genoa Police Department; and
- e. The Beer Garden temporary permit may extend to weekends through July 2017 subject to the said ordinance except for language pertaining to Genoa Days; and
- f. Live music shall not be audible off the premises at decibel levels greater than normal back ground noise after 11:00 p.m. on Friday and Saturday and 10 p.m. on Sunday; and
- g. Violations of City Ordinance shall result in shutting down the temporary Beer Garden for that evening, and if necessary, the City may revoke the special permit.

SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgement shall not affect, impair, invalidate or nullify the remainder thereof, which remain and continue in full force and effect.

Section 4: All ordinance or parts of ordinances in conflict herewith and hereby repealed to the extent of such conflict.
