ORDINANCE NO. 2018 - 30

AN ORDINANCE ABATING THE TAX HERETOFORE LEVIED FOR THE YEAR 2018 TO PAY THE PRINCIPAL OF AND INTEREST ON \$550,000 GENERAL OBLIGATION BONDS, SERIES 2010 OF THE CITY OF GENOA, ILLINOIS.

WHEREAS, the City Council of the City of Genoa, DeKalb County, Illinois, by ordinance 2010-17 adopted on the 21st day of September, 2010 (the "Ordinance"), did provide for the issue of \$550,000 General Obligation Bonds, Series 2010, (the "Series 2010 Bonds"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Series 2010 Bonds; and

WHEREAS, the City will have Pledged Revenues (as defined in the Ordinance) available for the purpose of paying the principal of and the interest on the Series 2010 Bonds up to and including December 1, 2019; and

WHEREAS, it is necessary and in the best interest of the City that the tax heretofore levied for the year 2018 to pay the principal of and interest on the Series 2010 Bonds be abated:

NOW, THEREFORE, Be it Ordained by the City Council of the City of Genoa, DeKalb County, Illinois, as follows:

SECTION 1: Abatement of Tax for Series 2010 Bonds: The tax heretofore levied for the year 2018 in the Ordinance for the Series 2010 Bonds in the amount of \$67,515.00 is hereby abated in its entirety.

SECTION 2: Filing of Ordinance: Forthwith upon the adoption of this ordinance, the City Clerk shall file a certified copy hereof with the County Clerk of DeKalb County, Illinois and it shall be the duty of said County Clerk to abate said tax levied for the year 2018 in accordance with the provisions hereof.

SECTION 3: Effective Date: This ordinance shall be in full force and effect forthwith upon its passage by the City Council and signing and approval by the Mayor.

PASSED by the City Council of the City of Genoa, Illinois at a regular meeting of the City Council thereof held on December 4, 2018, and approved by me as Mayor on the same day.

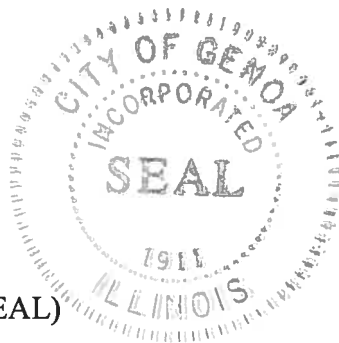
