AN ORDINANCE LEVYING SPECIAL SERVICE AREA PROPERTY TAXES FOR THE SPECIAL SERVICES TO BE PROVIDED IN RIVER BEND SPECIAL SERVICE AREA IN THE CITY OF GENOA, DEKALB COUNTY, ILLINOIS FOR THE FISCAL YEAR COMMENCING ON THE 1ST DAY OF MAY, 2018 AND ENDING ON THE 30TH DAY OF APRIL, 2019.

WHEREAS, the City Council of the City of Genoa, DeKalb County, Illinois, by ordinance number 2004-42 adopted on the 5th day of October, 2004 (the "Ordinance"), did provide for the establishment of River Bend Special Service Area, and the levy of a direct annual tax, not to exceed fifty cents (\$0.50) per \$100 equalized assessed valuation, per year, per dwelling unit, to pay for the special services to be provided to the residents of the aforementioned special service area;

NOW, THEREFORE, Be it Ordained by the City Council of the City of Genoa, Dekalb County, Illinois, as follows:

SECTION 1: A special service property tax of \$63,430.00 (sixty-three thousand four hundred thirty dollars) or so much as is authorized by law is hereby levied against all taxable property in River Bend Special Service Area, in the City of Genoa, DeKalb County, Illinois, subject to taxation for the year 2018 to defray the expenses for special services of River Bend Special Service Area for the fiscal year beginning the 1st day of May, 2018 and ending the 30th day of April, 2019.

SECTION 2: Effective Date: This Ordinance shall be in full force and effect forthwith upon its passage by the City Council and signing and approval by the Mayor.

Passed by City Council of the City of Genoa, Illinois at a regular meeting of the City Council thereof held on December 4, 2018 and approved by me as Mayor on the same date.
