## ORDINANCE NO. 2019-

## AN ORDINANCE AMENDING TITLE 6, MOTOR VEHICLES AND TRAFFIC CHAPTER 2, STOPPING, STANDING AND PARKING, SECTION 4 OF THE CITY CODE OF THE CITY OF GENOA

BE IT ORDAINED by the Mayor and City Council of the CITY OF GENOA, DeKalb County, Illinois, as follows:

WHEREAS, it is necessary to amend the Municipal Code from time to time; and

WHEREAS, the City of Genoa has the ability to amend the Code to allow Police Officers to write a City Ordinance Citation rather than a State Citation;

WHEREAS, the fine for a City Ordinance Citation would be more reasonable than the State Citation;

NOW THEREFORE, the Municipal Code of the City of Genoa be amended as follows:

SECTION 1: That Title 6, Chapter 2, Section 4, subsection C be amended to instead read:

C. No person may drive, stop, park or leave standing upon a public street, highway, or roadway a vehicle upon which is displayed an Illinois registration plate or plates or registration sticker after the termination of the registration period for which the registration plate or plates or registration sticker was issued for after the expiration date set under section 3-414 of the Illinois Vehicle Code (625 ILCS 5/3-414).

SECTION 2: That Title 1, Chapter 4, Section 1 be amended to instead read:

6-2-4-C <del>Vehicle parked on street with Expired Registration \$ 20</del>

SECTION 3: This ordinance shall be in full force and effect from and following its passage and approval.
