H) APPROVE A RESOLUTION RELEASING A MORTGAGE FOR LOT 77 IN THE RIVERBEND SUBDIVISION IN ACCORDANCE WITH THE RIVERBEND ADDITION TO GENOA DEVELOPMENT AGREEMENT

At the time By Grainger acquired the unimproved property in the Riverbend Subdivision, the City entered into a Development Agreement with the owner which included requirements for the completion of the public improvements in the subdivision in Units 1-6. To ensure these improvements were completed, the City holds a mortgage on the commercial property owned by the Developer at the north end of the subdivision along Route 72. Release of the mortgage and note is to occur as the improvements are completed (Lot 77 when Units 1-5 are completed and Lot 1A when Unit 6 is completed). The Developer has now completed the improvements in

Units 1-5, which have been reviewed and inspected by the Public Works Director, and the Developer is now requesting the release of the mortgage on Lot 77. Unit 6 will also soon be completed at which time the note will be cancelled and the mortgage for Lot 1A will also be released.

I) DISCUSSION REGARDING THE CITY OF GENOA'S SAFE ROUTES TO SCHOOL GRANT APPLICATION
