#### **DEPARTMENT REPORTS:**

#### FINANCE:

City Administrator Seguss spoke on behalf of Finance Director Jan Tures. Seguss announced that there should be a presentation at the next meeting regarding the audit and its results. She also told the council that the finance department has been wrapping up looking at quotes for liability and health insurance for the city.

#### **PUBLIC WORKS:**

Public Works Director Janice Melton explained that they are working on planting the rest of the trees from the tree grant and they have about 40 left. They also decorated downtown for the beginning of fall.

# *POLICE:*

Police Chief Robert Smith went over the recent activity as far as calls and arrests. He addressed a situation that included a Facebook post that gave false information about an injury outside of one of the elementary schools. The injury was between two students and was deemed accidental. They've taken 21 police reports, 5 of them being arrests since the last time the council has met. The PD also participated in school drills with Camelot, GKMS and KES. All the officers within the department qualified at the range as well.

# *ADMINISTRATION:*

City Administrator Alyssa Seguss had no report but opened the floor up to answer any questions the council may have. There was then a discussion regarding the façade grants that are in motion downtown and updates on the businesses including Trackside, Warehouse on Park, Napa and Genoa Gaming. Seguss also then mentioned that there will be a notice in the paper soon stating they will be accepting bids for the downtown revitalization project.

#### **CLOSED SESSION**

Alderman Winter made a motion to go into a closed session for the purpose of approving the minutes of the previous closed session and for the purpose of discussing land acquisition and the sale of public property, seconded by Alderman Roca.
