ORDINANCE NO. 2023 - 22

**AN ORDINANCE LEVYING SPECIAL SERVICE AREA PROPERTY TAXES FOR THE SPECIAL SERVICES TO BE PROVIDED IN DERBY ESTATES SPECIAL SERVICE AREA IN THE CITY OF GENOA, DEKALB COUNTY, ILLINOIS FOR THE FISCAL YEAR COMMENCING ON THE 1<sup>ST</sup> DAY OF MAY, 2023 AND ENDING ON THE 30<sup>TH</sup> DAY OF APRIL, 2024.**

WHEREAS, the City Council of the City of Genoa, DeKalb County, Illinois, by ordinance number 2005-30 adopted on the 16th day of August, 2005 (the “Ordinance”), did provide for the establishment of Derby Estates Special Service Area, and the levy of a direct annual tax, not to exceed fifty cents (\$0.50) per \$100 equalized assessed valuation, per year, per dwelling unit, to pay for the special services to be provided to the residents of the aforementioned special service area; and

WHEREAS, Illinois statutes (35 ILCS 200/27-75) authorize the corporate authorities to levy taxes in the same year in which the Ordinance is filed with the county clerk:

NOW, THEREFORE, Be it Ordained by the City Council of the City of Genoa, Dekalb County, Illinois, as follows:

SECTION 1: A special service property tax of \$9,180.00 (nine thousand one hundred eighty dollars) or so much as is authorized by law is hereby levied against all taxable property in Derby Estates Special Service Area, in the City of Genoa, DeKalb County, Illinois, subject to taxation for the year 2023 to defray the expenses for special services of Derby Estates Special Service Area for the fiscal year beginning the 1<sup>st</sup> day of May, 2023 and ending the 30<sup>th</sup> day of April, 2024.

SECTION 2: Effective Date: This Ordinance shall be in full force and effect forthwith upon its passage by the City Council and signing and approval by the Mayor.

Passed by City Council of the City of Genoa, Illinois at a regular meeting of the City Council thereof held on December 6, 2023 and approved by me as Mayor on the same date.


