**ORDINANCE NO. 2024- 12**  
**AN ORDINANCE CREATING TITLE 2, CHAPTER 10, COMPREHENSIVE AND STRATEGIC PLANNING COMMITTEE, OF THE CITY OF GENOA**

WHEREAS, a Comprehensive and Strategic Planning Committee would allow for community oversight of goals outlined in the Comprehensive and Strategic Plans; and

NOW THEREFORE BE IT ORDAINED by the Mayor and City Council of the CITY OF GENOA, DeKalb County, Illinois, as follows:

SECTION 1: That Title 2, Chapter 10, of the City Code of the City of Genoa read as follows:

**2-10-1: Creation, Composition and Terms**

**~~2~~10-1: CREATION, COMPOSITION AND TERMS:**

- A. A Comprehensive and Strategic Planning Committee is hereby authorized and established.
- B. Appointment and Terms. The Comprehensive and Strategic Planning Committee shall consist of five (5) members appointed by the Mayor with the advice and consent of the City Council. Each member shall be appointed for a term of 5 years.
- C. Ex Officio Members: The Mayor shall serve as an ex officio member of the Commission.

**~~2~~10-2 MISSION AND DUTIES:**

The Comprehensive and Strategic Planning Committee shall be advisory to the City Council. The Comprehensive and Strategic Planning Committee shall work in cooperation with the City Council, Departments and community members to analyze the City's Comprehensive and Strategic Plans, expand on the City's Comprehensive and Strategic Plan Action Plans, and report quarterly to the City Council regarding progress towards achieving community goals. Additionally, the Comprehensive and Strategic Planning Committee's role is to provide recommendations to the City Council in regards

to programs, policies, and budgetary items to aid in the achievement of Comprehensive and Strategic Plan goals outlined by the community.

## **2-10-2 MEETINGS AND RULES:**

Meeting dates and times shall be established on an annual basis and published in the City's Annual Meeting Calendar on the City website. Meetings shall comply with the Illinois Open Meetings Act.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: This Ordinance shall be in full force and effect following its passage, as provided by law.

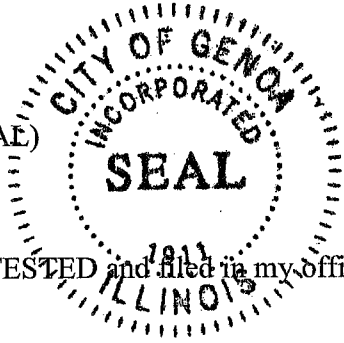
